



## Tax Saver Commuter Tickets Explained

Tax Saver Commuter Tickets is an initiative of the Revenue Commissioners introduced in 1997 which exempts employees from benefit-in-kind taxation when purchasing an annual commuter travel ticket for bus or rail via salary sacrifice with their employer.

### How it Works?

- The expense must be incurred by the employer on the employee's behalf.
- The employee enters a salary sacrifice arrangement whereby their gross income is reduced by the cost of the annual tax saver ticket and they will not be charged tax on the remuneration sacrificed.
- The employer is allowed treat the cost of the tax saver ticket as an expense for their records.

### How Do I Apply?

#### STEP 3

Submit your photo or existing photo ID number (if required).

A copy of your purchase agreement can be viewed & downloaded anytime by logging on.



**Following approval you'll receive your ticket. You don't pay cash, instead the cost is deducted from your salary over 1 – 12 months. Once you have registered you can login and track your order details.**
